The franchise is for the establishment and operation of a Cobblestone Inn & Suites® or Cobblestone Hotel & Suites® lodging facility (collectively referred to in this document as "Cobblestone Lodging Facilities".

The total investment necessary to begin operation of a Cobblestone Lodging Facility franchised business is between \$2,485,899 and \$7,363,000. This includes between \$48,899 and \$73,000 that must be paid to the franchisor or its affiliate(s).

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.
