As a franchisee, you will operate a learning center providing child focused educational programs, including subjects such as computer programming, coding, math, logic and teamwork, under the name "Code Ninjas"

The total investment necessary to begin operation of a Code Ninjas franchise is from \$128,000 to \$223,000 This includes \$42,000 to \$50,000 that must be paid to us as the franchisor or our affiliate. Please see Items 5 and 7 for additional details

We may offer to enter into an area development agreement to establish and operate a certain number of Code Ninjas franchises at specific locations pursuant to individual franchise agreements. The area development fee will be equal to \$20,000 multiplied by the number of Code Ninjas franchises to be developed under the area development agreement The area development fee will then be credited, in increments of \$20,000, toward the franchise fee owed for each Code Ninjas franchise developed. Your estimated initial investment will vary based on the number of centers to be developed

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English Read this Disclosure Document and all accompanying agreements carefully You must receive the Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale Note, however, that no government agency has verified the information contained in this document
