You will publish within an exclusive territory a free weekly restaurant publication called **Coffee News** for the patrons of restaurants, coffee shops, and other food related businesses.

The total investment necessary to begin operation of a Coffee News franchise is \$8,925.00. This includes \$8,000.00 that must be paid to the franchisor, COFFEE NEWS USA, INC. ("we or us) \$5,000.00 must be paid to us for each additional franchise up to a maximum of 20 franchises per individual or company.
