The total investment necessary to begin operation of a College Pro franchise is \$2,825925 to \$13,91014,010. This includes \$500600 to \$3,800900 that must be paid to College Pro or an affiliate prior to beginning operations and \$2,250350 to \$10,125225 that must be paid to College Pro or an affiliate during the first 3 months of operations.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION ONLY IN THE STATE IN WHICH THE FRANCHISED BUSINESS IS OPERATED. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN THE STATE IN WHICH THE FRANCHISED BUSINESS IS OPERATED THAN IN YOUR OWN STATE.

- 2. THE FRANCHISE AGREEMENT STATES THAT THE LAW IN WHICH THE FRANCHISED BUSINESS IS OPERATED GOVERNS THE AGREEMENT AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 33. IF YOU TERMINATE THE FRANCHISE PRIOR TO THE END OF THE TERM OF THE FRANCHISE AGREEMENT AND DEPENDING ON WHEN YOU TERMINATE, YOU MAY BE REQUIRED TO PAY DAMAGES TO COLLEGE PRO IN THE AMOUNT OF A MINIMUM OF \$3,000.
- 4. YOU ARE REQUIRED TO PAY CERTAIN FEES TO COLLEGE PRO EVEN IF YOU HAVE NO REVENUE.
- 5. APPROXIMATELY 126 FRANCHISEES OR 33% OF FRANCHISEES WHO SIGNED FRANCHISE AGREEMENTS FOR THE YEAR 2014, TERMINATED THE FRANCHISE BEFORE THE END OF THE FRANCHISE TERM. OF THE FRANCHISEES WHO COMPLETED THE FRANCHISE TERM, APPROXIMATELY 62% DID NOT MEET THE SALES TARGET WE ESTABLISHED, IN OUR DISCRETION, FOR FRANCHISEES.
- 6. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
