College Pro Painters (U.S.) Ltd. offers exterior residential painting franchises.

The total investment necessary to begin operation of a College Pro franchise is \$2,925 to \$14,010. College Pro does not require an initial franchise fee, but this includes \$600 to \$3,900 that must be paid to College Pro or an affiliate prior to beginning operations and \$2,350 to \$10,225 that must be paid to College Pro or an affiliate during the first 3 months of operations.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
