The total investment necessary to begin operation of a College Pro franchise is \$4,320 to \$13,870. This includes \$2,820 to \$6,770 that must be paid to College Pro or an affiliate.

OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES.
