The total investment necessary to begin operation of a College Pro franchise is \$4,220 to \$13,770. College Pro does not require an initial franchise fee, but this includes \$2,720 to \$6,670 that must be paid to College Pro or an affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
