Our franchisees offer quality residential and commercial painting and related products and services to the public under the "Color WorldTM" names.

The total investment necessary to begin operation of a **COLOR WORLD** franchise is between **\$59,260** to **\$130,200**. This includes \$40,000 to \$43,000 that must be paid to us or our affiliate.
