We offer franchises for a dry cleaning and laundry business. -There are two types of franchises: a “Comet Plant Store,” which processes on-site the clothing deposited by customers (except for specialty items), and a “Comet Pick Up Store,” which is a facility where customers deposit clothing for processing at an approved off-site dry cleaning and laundering plant.

The total initial investment necessary to begin operation of a single Comet Plant Store ranges from ~~\$469,000~~ \$501,375 to ~~\$739,000~~ -\$794,500. This includes ~~\$355,100~~ \$380,000 that must be paid to us or our affiliates. - The total initial investment necessary to begin operation of a single Comet Pick Up Store ranges from ~~\$841,000~~ \$0 to ~~\$142,300~~ -\$205,600. This includes ~~\$55,000~~ \$0 to \$65,000 that must be paid to us or our affiliates.

The total investment necessary for a Pick Up Store Option Agreement is \$10,000 to \$30,000, assuming that the agreement covers 1-3 Comet Pick Up Stores. -You pay all of this amount to us as the option fee for the Comet Pick Up Stores.

This Disclosure Document summarizes certain provisions of your license agreement and other information in plain English. -Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. -**Note, however, that no governmental agency has verified the information contained in this Disclosure Document.**
