Non-Medical Home Care Franchise

ComForCare Health Care Holdings, LLC ("ComForCare") offers franchises for the operation of a ComForCare Home Care or ComForCare Senior Services (hereinafter, together referred to as "ComForCare Home Care") franchised business that provide: (1) affordable, efficient companionship and personal/domestic care services, and other special needs services, primarily on a non-medical basis, for seniors and people of all ages so that they may remain in their residences, (2) supplemental healthcare staffing services for persons who need this kind of assistance in their home or a facility in which they reside, and (3) private duty nursing services (skilled, medical services).

The initial franchise fee for a territory with a population of between 15,000 and 25,000 people over the age of 65 is \$38,000. The initial franchise fee for a territory with a population of between 25,000 and 35,000 people over the age of 65 years is \$48,000.

The total investment necessary to begin operation of a new ComForCare Home Care franchise that provides the first and second lines of service outlined above is \$76,650-\$175,000 which includes the \$38,000 or \$48,000 initial franchise fee which must be paid to ComForCare or an affiliate.

The total investment to begin operation of a new ComForCare Home Care franchise that provides all three lines of service outlined above is \$133,400-\$263,500 which includes the \$38,000 or \$48,000 initial franchise fee which must be paid to ComForCare or an affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
