The franchise offered in this disclosure document is for the rights to own and/or operate a COMFORT INN®, COMFORT SUITES® or COMFORT INN & SUITES® ("COMFORT") hotel business ("COMFORT").

The total investment necessary to convert an existing hotel and begin operation of an 80-room COMFORT INN, COMFORT INN & SUITES, or COMFORT SUITES hotel franchise is between \$297,750 299,500 and \$1,687,5991,690,049. The total investment necessary to begin operation of a newly constructed \$487-room COMFORT INN or COMFORT INN & SUITES hotel franchise is between \$5,579,8004,145,482 and \$7,174,6496,900,975 and the total investment necessary to begin operation of a newly constructed \$785-room COMFORT SUITES hotel franchise is between \$6,740,4004,558,702 and \$8,414,4497,573,912. This includes an affiliation fee of \$500 per room, (\$50,000 minimum) for COMFORT INN, COMFORT INN & SUITES, or COMFORT SUITES; a property management system software license and systems training fee of between \$10,250 and \$14,250; and orientation and hospitality training fees of between \$0 and \$2,349 per person, all of which must be paid to the Franchisor or its affiliates. These sums do not include the cost of purchasing or leasing land or any real estate taxes.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to us or our affiliates in connection with the proposed franchise sale or grant. **Note, however, that no governmental agency has verified the information contained in this document.**

EXCEPT FOR CLAIMS AGAINST YOU FOR INDEMNIFICATION AND ACTIONS SEEKING TO STOP YOU FROM USING OUR MARKS IN VIOLATION OF THE FRANCHISE AGREEMENT, THE FRANCHISE AGREEMENT REQUIRES THAT ALL DISAGREEMENTS BETWEEN US BE SETTLED BY ARBITRATION. ALL ARBITRATIONS WILL BE CONDUCTED IN MARYLAND. OUT OF STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN MARYLAND THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT MARYLAND LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
