Comfort Dental Group, Inc., a Colorado corporation, is offering franchises for the operation of dental offices under the service mark "Comfort Dental." The total estimated investment necessary to begin operation of a COMFORT DENTAL branded dental office ranges from \$649,000 to \$822,000. This includes between \$610,000 to \$768,000 that must be paid to the franchisor or affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
