Comfort Dental Group, Inc., a Colorado corporation, is offering master franchises to Master Franchisors to sell COMFORT DENTAL subfranchises and then to provide site acquisition, development and ongoing support services to Subfranchisees located in a particular geographic area. The total investment necessary to begin operation of a COMFORT DENTAL subfranchise is between \$120,200 and \$160,000. This includes \$50,000 that must be paid to the franchisor or affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
