We are ConnectShare Franchise, Inc., a Utah corporation doing business as ConnectShare. We offer franchises to qualified individuals and entities to own and operate business networking franchises under our ConnectShare™ service marks, trade names, programs, and systems. Our franchisees offer quality networking events, activities, products, and services to the public under the service marks and the ConnectShare programs and systems (the "Method of Operation").

The total investment necessary to begin operation of a ConnectShare franchise is \$71,010 to \$97,020. This includes \$50,500 to \$53,000 that must be paid to us or our affiliate. Your initial investment and initial fees are more fully described in Items 5, 6 and 7 of this Disclosure Document.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

IT MAY ALSO COST YOU MORE TO SUE, ARBITRATE, OR MEDIATE WITH US IN UTAH THAN IN YOUR OWN STATE.
- 2) THE FRANCHISE AGREEMENT STATES THAT UTAH LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
