This Franchise Disclosure Document is for a Consignit Couture store. A Consignit Couture store is a high end woman's consignment boutique Through this Consignit Couture store, the franchisee will operate a retail resale and consignment business which primarily involves the purchase and resale of both new and "gently used" designer label clothing and accessories to a targeted consumer market. Franchisees will also enjoy the opportunity to use their store consigned merchandise as online inventory to place on the Consignit Couture company online ecommerce site.

The total investment necessary to begin operation of a Consignit Couture franchise is from \$99,300 to \$220,500. This includes \$30,000 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
