The franchisee will operate a Contender eSports Game Center. We offer two programs:

<u>Single Unit Program:</u> The total investment necessary to begin operation of a Contender eSports Game Center franchised business ranges from \$135,400 to \$218,680. This includes the initial franchise fee of \$25,000 that must be paid to the franchisor or its affiliate(s).

<u>Multi-Unit Program:</u> The total investment necessary to begin operations of a Contender eSports Game Center franchised business ranges from \$179,900 to \$287,080 (a minimum of two to three but can be more if you are qualified to develop more than six Contender eSports Game Centers). The initial development fee ranges from \$19,500 (to develop one additional franchise) to \$39,000 (to develop two additional franchises).
