COOL CUTS 4 KIDS® Businesses provide value priced hair care services primarily for children, and sell a complete line of hair care products, merchandise and appliances.

The total investment necessary to begin operation of a COOL CUTS 4 KIDS is \$107,998 to \$189,030. This includes \$25,500 to \$47,500 that must be paid to the franchisor or affiliate. You might pay the franchisor more if you sign a Development Agreement for multi-unit development (see Item 5).

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully.
