The franchise is offered for the operation of a Copeland's of New Orleans Restaurant ("Copeland's Restaurant" or "Restaurant") specializing in New Orleans cuisine under the Copeland's of New Orleans System ("System").

The total investment necessary to begin the operation of a Copeland's Restaurant ranges from \$2,212,579 to \$3,497,279. This includes \$70,000 to \$75,000 that must be paid to us or our affiliate. The total investment range does not include the cost of real estate and improvements or the cost of obtaining a liquor license.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
