The franchise is offered for the operation of a Copeland's of New Orleans Restaurant ("Copeland's Restaurant") specializing in New Orleans cuisine under the Copeland's of New Orleans System ("System").

The total investment necessary to begin the operation of a Copeland's Restaurant ranges from \$3,522,579 to \$4,447,279. This includes \$70,000 to \$75,000 that must be paid to us or our affiliate. The total investment range does not include the cost of real estate, security deposit or liquor license.

If you enter into a Development Agreement, with respect to each Restaurant developed thereunder, you must pay us a development fee of \$20,000 and an initial franchise fee of \$40,000. If you do not enter into a Development Agreement, with respect to each Restaurant, you must pay us an initial franchise fee of \$60,000.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind. OUT-OF-STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT ALSO MAY COST YOU MORE TO LITIGATE WITH US IN LOUISIANA THAN IN YOUR OWN STATE.
