As a franchisee, you will operate a CORPORATE CLEANING GROUP Business providing commercial, industrial and institutional cleaning and maintenance services.

The total investment necessary to being operation of a CORPORATE CLEANING GROUP franchise business is from \$10,140 to \$54,640. This includes an initial franchise fee of \$15,000 that must be paid to the Franchisor. If you have been in the commercial cleaning service business for six months, the initial franchise fee is waived.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least fourteen (14) calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

You may wish to receive your disclosure document in another format that is more convenient for you. - 2. THE FRANCHISE AGREEMENT STATES THAT MICHIGAN LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTION AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.**
