BSO Beauty Supply Express Outlet® Businesses provide professional salon hair care and beauty products and accessories in addition to the provision of consistent, convenient, high-fashion, quality, hairstyling and hair care services, generally including hairstyling, hair colour, perms, haircuts, shampoos, conditioning and blow-drys. The business system may also include beauty services, generally including nail care, skin and body care, aesthetics, wax, tanning and hair extensions.

The total investment necessary to begin operation of a BSO BEAUTY SUPPLY EXPRESS OUTLET® is \$216,380 to \$293,600. This includes \$100,500 to \$127,500 that must be paid to the franchisor or affiliate.
