As a franchisee, you will operate an automotive shop that repairs, remanufactures and services transmissions and other driveline related component parts (including batteries, electrical, cooling and radiator) under the trade name Cottman Transmission (the "Cottman Center").

We offer Cottman Center franchises only to: (1) existing Cottman franchisees who are renewing an existing Cottman License Agreement; (2) purchasers of an operating Cottman Center from an existing Cottman franchisee and who meet our qualifications; and (3) purchasers of a recently closed Cottman Center who will re-open and operate that center and who meet our qualifications.

The total investment necessary to begin operation of a new Cottman Transmission franchised business ranges from \$192,199 to \$230,499. This includes \$58,599 to \$70,099 that must be paid to the franchisor and/or its affiliate(s).

The total investment necessary to renew a Cottman Center that requires no refurbishing is \$0, since we do not charge a renewal fee. The total investment for a buyer of an existing Cottman Center will be \$13,000, consisting of the initial fees that must be paid to us, plus the purchase price for the business payable to the selling franchisee (or us, as applicable) and the cost of any refurbishing. We cannot estimate if refurbishing will be required as that depends on the physical condition of the particular Cottman Center at the time of renewal or transfer.

This disclosure document summarizes certain provisions of your License Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

You may wish to receive your disclosure document in another format that is more convenient for you.
