

FRANCHISE DISCLOSURE DOCUMENT

The franchisor's name is Country Waffles, Inc. It is a California corporation. Its principal business address is 720 E. North Ave., Suite 108, Fresno, California 93725, telephone number (559) 233-4330.

The franchised business is a restaurant business serving only breakfast and lunch during the hours of 6:00 A.M. to 3:00 P.M.

The total investment necessary to begin operation of a Country Waffles franchise is between \$241,000 and \$478,000. This includes \$20,000 that must be paid to the franchisor or affiliate.
