

## FRANCHISE DISCLOSURE DOCUMENT

The franchisor's name is Country Waffles, Inc. It is a California corporation. Its principal business address is 720 E. North Ave., Suite 108, Fresno, California 93725, telephone number (559) 233-4330.

The franchised business is a restaurant business serving only breakfast and lunch during the hours of 6:00 A.M. to 3:00 P.M. or, alternatively, during such hours as you and CW agree. The menu includes typical breakfast and lunch items, including many kinds of waffles.

The total investment necessary to begin operation of a Country Waffles franchise is between \$418,000 and \$746,000. This includes \$35,000 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES IF YOU DO NOT LIVE IN CALIFORNIA. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN CALIFORNIA THAN IN YOUR OWN STATE.

2. THE FRANCHISE AGREEMENT STATES THAT CALIFORNIA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW IF YOU DO NOT LIVE IN CALIFORNIA. YOU MAY WANT TO COMPARE THESE LAWS.

3. THE FRANCHISOR IS UNDER NEW OWNERSHIP AND DOES NOT HAVE A LONG OPERATING HISTORY.
