We are CML Franchise LLC a California limited liability company. We offer franchises to qualified individuals and entities to own and operate a Cousins Maine Lobster franchise under our service marks, trade names, programs and systems under the name(s) "Cousins Maine Lobster," (the "Marks"). Our franchisees own and operate a gourmet mobile food truck serving lobster under the Marks and the Cousins Maine Lobster programs and systems (the "Method of Operation").

The total investment necessary to begin operation of Cousins Maine Lobster franchise is \$145,900 to \$359,900. This includes between \$58,500 and \$78,500 that must be paid to franchisor or its affiliate(s).

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate of franchisor in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
