We are Craft Beer Stellar, a Massachusetts limited liability company. We offer franchises to qualified individuals and entities to own and operate a Craft Beer Cellar franchise under our service marks, trade names, programs, and systems under the names "Craft Beer Cellar," (the "Marks"). Our franchisees operate a retail beer store focused on the sale of craft, micro, and artisanal brewed beers under the Marks and the Craft Beer Cellar programs and systems (the "Method of Operation").

The total investment necessary to begin operation of a Craft Beer Cellar franchise is \$55,325 to \$182,000. This estimate is only approximate. This includes the \$20,000 Initial Franchise Fee that must be paid to us.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

OUT-OF-STATE LITIGATION AND MEDIATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO SUE OR MEDIATE WITH US IN MASSACHUSETTSTHAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT MASSACHUSETTS LAW GOVERNS THIS AGREEMENT, AND MASSACHUSETTS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

WE PAY THIS PERSON A FEE FOR SELLING OUR FRANCHISE OR REFERRING YOU TO US. YOU SHOULD BE SURE TO DO YOUR OWN INVESTIGATION OF THE FRANCHISE.
