The franchise offered is for a business of shipping, packaging, crating, receiving and delivery, storage, transportation, moving, logistics, blanket wrap, and freight forwarding services and products for individuals and companies (the "Franchise"). The packaging and crating techniques are specifically designed for the product. The focus of the business is to accommodate companies or individuals in assuring sufficient packaging and delivery to arrive on time and safely. The Franchisee will not participate in any other business.

The total estimated investment necessary to begin operation of a Craters & Freighters franchise is \$155,300 to \$251,500. This includes an initial franchise fee of \$35,000 that must be paid to the franchisor or affiliate for a full market territory with a population of 1,000,000 people. If you request, and we approve, a full market territory with a population of more than 1,000,000 people, then you will be required to pay us a supplemental territory fee of \$0.015 per additional person in the full market territory.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note however, that no governmental agency has verified the information contained in this document.**

- 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION OR LITIGATION ONLY IN COLORADO. OUT OF STATE ARBITRATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE OR LITIGATE WITH US IN COLORADO THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT REQUIRES THAT COLORADO LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. A COMPANY THAT IS NO LONGER OUR AFFILIATE WILL CONTINUE TO SOLICIT BUSINESS FOR YOU AND YOU ARE REQUIRED TO ACCEPT SUCH BUSINESS AND PERFORM THE WORK AT THE PRICES THAT COMPANY NEGOTIATED FOR YOU. THIS REQUIREMENT MAY REDUCE YOUR ANTICIPATED REVENUE AND NET INCOME.
- 4. YOU MUST MAINTAIN A MINIMUM SALES PERFORMANCE LEVEL, AND PAY A MINIMUM MONTHLY ROYALTY FEE. FOR A FULL MARKET TERRITORY, THESE LEVELS MAY BE INCREASED FOR YEARS 4-15 AT THE FRANCHISOR'S DISCRETION. IF YOU FAIL TO MEET THESE LEVELS FOR EITHER TYPE OF MARKET, YOUR FRANCHISE TERRITORY COULD BE REDUCED OR THE FRANCHISOR COULD TERMINATE YOUR AGREEMENT AND YOU COULD LOSE YOUR INVESTMENT.
 - 5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should make sure to do your own investigation of the franchise.
