The franchise offered is for a quick-serve “Crave” restaurant offering hot dogs, other cased meats, barbeque items, beverages, appetizers and side dishes. Your restaurant will also offer beer and may serve wine. A Crave restaurant operates using the franchisor’s proprietary recipes, formulae, techniques, trade dress, trademarks and logos.

The total investment necessary to begin operation of a Crave Restaurant franchise is \$190,400 to \$512,500. This includes \$35,000 to \$40,000 that must be paid to the franchisor and/or its affiliate, as appropriate.

If you enter into a Multi-Unit Development Agreement to develop at least three restaurants, you will pay a reservation fee equal to \$20,000 for each restaurant you commit to develop under the Multi-Unit Development Agreement. The estimated initial investment to develop three Crave restaurants is \$232,400 to \$555,000. This includes \$75,000 to \$80,000 that must be paid to the franchisor and/or its affiliate, as appropriate. The total investment under a Multi-Unit Development Agreement will vary depending on the number of restaurants to be developed.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

IT MAY ALSO COST YOU MORE TO ARBITRATE AND LITIGATE WITH US IN DELAWARE THAN IN YOUR OWN STATE.
