The franchise is for the establishment and operation of an early childhood learning center, a child care facility and creative development school featuring child care and daily care products and services for children ages 6 weeks to 12 years under the <u>CREATIVE WORLD SCHOOLCreative World School</u>® trade name and business system (a "<u>CREATIVE WORLD SCHOOLCreative World School</u>® **Business**" or "**School**").

The total investment necessary to begin operation of a <u>CREATIVE WORLD SCHOOL®Creative</u> <u>World School® Business</u> ranges from \$1,691,300 to \$4,109,000. See Item 7.1.691,375 to \$4,109,075. These totals include the amount of \$385,000 to \$490,000 that is paid to us or our affiliates. <u>See Item 5.</u>
