The franchised business is to operate a education and after school program business under the trade name “Curie Learning”

The total investment necessary to begin operation of a Curie Learning franchise is \$66,650 to \$97,750 This includes \$25,000 that must be paid to the franchisor or affiliate If you sign a multi-unit development agreement, you will have a total additional investment of \$41,000 to \$85,000 for the rights to develop three to five locations Of this, \$40,000 to \$80,000 would be paid to the franchisor or affiliate
