The franchisee will operate a thirty minute fitness and weight-loss center to offer instruction to the general public on weight reduction and fitness.

The total investment necessary to begin operation of a Curves franchise is \$42,225 to \$55,100. This includes \$39,900 or \$34,900 that must be paid to the franchisor or affiliate. This sum does not include any real estate costs.
