The franchisee will operate a thirty minute fitness and weight-loss center to offer instruction to the general public on weight reduction and fitness.

The total investment necessary to begin operation of a Curves franchise is \$46,070.17 to \$69,443.14. This includes \$39,900 or \$34,900 that must be paid to the franchisor or affiliate. This sum does not include any real estate costs.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully.
