The franchisor, D.P. Dough Franchising, LLC (“D.P. Dough,” “us” or “we”), is in the business of operating and franchising restaurants under the “D.P. Dough” name that feature calzones, desserts, wings, and other food and beverage products. The franchisee will operate a D.P. Dough Restaurant.

The total investment necessary to begin operation of a D.P. Dough franchise ranges from \$291,540 to \$487,778. This includes a total of \$42,500 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
