The franchisee will operate a Days Inn<sup>®</sup> guest lodging facility franchise offering overnight accommodations and related services.

The total investment necessary to begin operation of a Days Inn franchise for an 89 room new construction facility ranges from \$4,699,200 to \$7,657,625. The total investment necessary to begin operation of a Days Inn franchise for a 100 room conversion facility ranges from \$167,352 to \$2,483,277. Land acquisition costs are not included in these ranges. The above amounts include a range of \$56,182 to \$91,362 that must be paid to the franchisor or an affiliate.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
