The franchise is offered for the sale, production and application of vehicle description window stickers to facilitate vehicle sales at automobile dealerships and the marketing and sale of various other authorized products and services we authorize to automobile dealerships under the Dealer Specialties International trade name and business system (a "DSI Business").

The total investment necessary to begin operation of a DSI business ranges from \$17,900 to \$44,900. These totals include an initial franchise fee of \$10,000 that must be paid to us.

This disclosure document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on this disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind.
