Decor & You franchises operate businesses that provide interior decorating to residential and commercial customers ("<u>DY Business(es)</u>"). We offer three franchises depending on the level of experience of the franchisee and support and training required. The Decor Coach franchise is for individuals looking to enter into the interior decorating business ("<u>Decor Coach Franchise</u>"), while the Styleprint Decor Designer franchise is for established interior designers and for those who desire to provide full-service interior design products and services ("<u>SDD Franchise</u>"). The Enterprise Firm consists of three Styleprint Decor Designer franchises operated as one outlet ("Enterprise Firm.")

The total investment necessary to begin operation of a Decor Coach Franchise or SDD Franchise is between \$34,640 and \$68,500. This includes \$17,000 that must be paid to the franchisor or its affiliates for a Decor Franchise or \$28,000 that must be paid to the franchisor or its affiliates for a SDD Franchise.

The total investment necessary to begin operation of an Enterprise Firm is between \$145,300 and \$178,940. This includes \$77,000 that must be paid to the franchisor or its affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

- 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY MEDIATION, ARBITRATION, AND/OR LITIGATION ONLY IN CONNECTICUT. OUT-OF-STATE MEDIATION, ARBITRATION, OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO MEDIATE, ARBITRATE, AND/OR LITIGATE WITH US IN CONNECTICUT THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT CONNECTICUT LAW GOVERNS THE AGREEMENTS, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

- 4. YOUR FRANCHISE BUSINESS HAS NO TERRITORIAL PROTECTION, AND WE AND OUR AFFILIATES HAVE THE RIGHT, WITHOUT ANY RESTRICTIONS, TO ENGAGE IN ANY AND ALL ACTIVITIES WE AND THEY DESIRE, IN COMPETITION WITH YOUR FRANCHISE.
- 5. THE FRANCHISOR MAY ESTABLISH MAXIMUM, MINIMUM, OR OTHER PRICING REQUIREMENTS TO THE FULLEST EXTENT ALLOWED BY LAW.
- 6. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source is our agent and represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
