As a franchisee, you will operate a studio offering clients signature exercise classes combining pilates, yoga, barre work and core strengthening, as well as full body rhythm based cycling classes, under the name "DEFINE body&mind"

The total investment necessary to begin operation of a DEFINE body&mind franchise is from \$226,050 to \$423,250 This includes an initial franchise fee of \$40,000 that must be paid to us, as well as certain pieces of equipment and certain supplies that must be purchased from us in the range of \$12,000 to \$15,000 Please see Items 5 and 7 for additional details

We may offer to enter into an area development agreement to establish and operate a certain number of DEFINE body&mind franchises at specific locations pursuant to individual franchise agreements. The area development fee will be equal to \$20,000 multiplied by the number of DEFINE body&mind franchises to be developed under the area development agreement. The area development fee will then be credited, in increments of \$20,000, toward the franchise fee owed for each DEFINE body&mind franchise developed Your estimated initial investment will vary based on the number of studios to be developed

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English Read this Disclosure Document and all accompanying agreements carefully. You must receive the Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale Note, however, that no government agency has verified the information contained in this document
