The franchise will offer salads and deli sandwiches of various types complimented with side dishes and beverages at competitive prices. This is a unique upscale deli restaurant dedicated to serving customers who seek quality sandwiches in a casual, relaxed environment enhanced by superior customer service, under the name "Deli Delicious[™]". The total estimated initial investment required for a Deli Delicious[™] express model ranges from \$116,800 to \$245,300 or from \$217,850 to \$462,150 for a Deli Delicious[™] standard model depending on a number of factors that are more fully discussed in Item 7. This includes the Initial Franchise Fee of \$20,000 for an express model or \$25,000 for a standard model (as discussed in Item5) that must be paid to the Franchisor or the Franchisor's affiliate.
