We offer franchises for the operation of mobile service centers offering cost effective one-stop shopping to practitioners and offices in the practice of general dentistry, endodontics, oral and maxillofacial surgery, orthodontics, pediatric dentistry, periodontics and prosthadontics as well as dental laboratories. The franchises will offer dental equipment maintenance, service and repair, handpiece repair, equipment sales, and consumable products relating to dentistry.

The total investment necessary to begin operating a Dental Fix Rx franchise is from \$68,100 to \$184,000. This includes the Initial Franchise fee of \$25,000 that must be paid to the franchisor or its affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. THE FRANCHISEE'S SPOUSE MUST SIGN A PERSONAL GUARANTY ACCEPTING JOINT AND SEVERAL LIABILITY FOR ALL OBLIGATIONS OF THE FRANCHISE REGARDLESS OF WHETHER SUCH SPOUSE IS INVOLVED IN THE OPERATION OF THE FRANCHISE BUSINESS.
