As a franchisee, you will operate a DentalSense branded dental clinic where you will provide and be responsible for patient dental care under a business management, operating and marketing system provided by DentalSense, LLC and other related services and products

The total investment necessary to begin operation of a DentalSense franchise is \$529,200 to \$804,300 This includes a \$35,000 Implementation Fee that must be paid to the franchisor or its affiliate

If you enter into a Multi-Unit Operator Agreement to develop at least six clinics, when you sign the Multi-Unit Operator Agreement you will pay a Multi-Unit Operator Fee equal to \$35,000 for the first clinic to be developed plus a deposit of \$13,000 multiplied by each additional clinic to be developed under the Multi-Unit Operator Agreement. The multi-unit operator fee is applied pro rata to the initial franchise fees due

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
