The total investment necessary to begin operation of a DESTINATION ATHLETE® franchised business is \$ 77,460 - \$132,835. This includes \$50,000.00 that must be paid to the franchisor or its affiliates. The range of fees is between \$20,000.00 and \$50,000.00.

OUT-OF-STATE LITIGATION, ARBITRATION, AND MEDIATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO LITIGATE, ARBITRATE AND MEDIATE WITH US IN NEW JERSEY THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT NEW JERSEY LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. IF FRANCHISEE IS A CORPORATION OR BUSINESS ENTITY EACH OWNER AND EACH OWNER'S SPOUSE MUST GUARANTEE ALL OBLIGATIONS OF THE FRANCHISE AGREEMENT, THEREBY PLACING PERSONAL ASSETS AT RISK.
- 4. IF YOU FAIL TO MEET REQUIRED SALES VOLUMES YOUR FRANCHISE CAN BE TERMINATED ON 30 DAYS NOTICE.
- 5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
