The franchisee will operate a DISCOVERY MAP® franchise, which is a multi-media alternative advertising program in the form of tourist and visitor information maps and guides supported by advertising purchased by restaurants, resorts, retail stores, local attractions and other tourist-based businesses in the community.

The total investment necessary to begin operation of a DISCOVERY MAP® franchise is estimated to be from \$35,250 to \$44,950. This includes the initial franchise fee of \$25,000 that must be paid to the franchisor. This is the total of all initial fees and payments for services or goods received from the franchisor and its affiliates before the business opens.

This disclosure document summarizes provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in the document.

BEFORE YOU BUY, CONSIDER WHAT RIGHTS YOU HAVE TO RENEW YOUR FRANCHISE, IF ANY, AND WHAT TERMS YOU MIGHT HAVE TO ACCEPT IN ORDER TO RENEW.

Please consider the following RISK FACTORS before you buy this franchise:

- 1. EXCEPT FOR CERTAIN CLAIMS, THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION ONLY IN VERMONT. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO ARBITRATE WITH US IN VERMONT THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT PERMITS THE FRANCHISEE TO SUE US ONLY IN VERMONT. OUT-OF-STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO SUE US IN VERMONT THAN IN YOUR HOME STATE. THE FRANCHISE AGREEMENT REQUIRES THAT WE AND YOU MAY NOT SEEK A TRIAL BY JURY.
- 3. THE FRANCHISE AGREEMENT STATES THAT VERMONT LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU WANT TO COMPARE THESE LAWS.
- 4. PLEASE NOTE THAT 81% OF FRANCHISOR'S ASSETS ARE INTANGIBLE. YOU MAY WANT TO TAKE THIS INTO CONSIDERATION WHEN MAKING A DECISION TO PURCHASE THIS FRANCHISE OPPORTUNITY.
- 5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
