DetailXPerts Franchise Systems, LLC is offering franchises for the operation of a business which provides mobile vehicle wash, detailing and related services.

The total estimated initial investment necessary to begin operation of a DetailXPerts franchise ranges from \$73,000 to \$182,000. This includes from \$43,000 to \$95,000 that must be paid to the franchisor or its affiliates. See Items 5, 6 and 7.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
