Device Pitstop, LLC offers individual franchises for the operation of Device PitstopSM stores (“Stores”) that buy, sell and service used and new consumer electronic devices, including laptops, tablets, digital music players, cell phones and accessories to retail customers.

The total investment necessary to begin operation of a Device PitstopSM store is from \$115,000 to \$199,000. This includes \$22,000 to \$33,000 that must be paid to us.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
