Device Pitstop, LLC offers individual franchises for the operation of Device PitstopSM stores (“Stores”) that buy, sell and service used and new consumer electronic devices, including laptops, tablets, digital music players, cell phones and accessories to retail customers.

The total investment necessary to begin operation of a Device PitstopSM store is from ~~\$115,000~~ \$156,000 to ~~\$199,000~~ \$215,000. This includes ~~\$22,000~~ \$24,000 to ~~\$33,000~~ \$32,000 that must be paid to us.
