The franchises described in this disclosure document are for the operation of a business specializing in the repair of cell phones, smart phones, tablets, laptops, desktop computers, and other electronic devices under the name **Digital Doc®**.

The total investment necessary to begin operation of a Digital Doc® franchise is between \$73,300 and \$151,100. This includes a \$29,000 franchise fee that must be paid to the franchisor and between \$8,000 and \$23,000 that must be paid to Our affiliate.

This disclosure document summarizes certain provisions of Your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully.
