The franchise offers to operate a food preparation and delivery business under the name "Dine In 2Nite" utilizing the trade names, procedures, and trade secrets given to them by Dine In 2Nite North America, Inc.

The total investment necessary to begin operation of a single Dine In 2Nite franchise ranges from \$49,700 to \$58,500 for a shared kitchen model and \$99,900 to \$157,750 for a full kitchen. This includes \$34,950 that must be paid to the franchisor or affiliate. It also includes a standard Equipment Package if building a full kitchen that you must purchase from Dine In 2Nite, affiliates or vendors for a cost of \$21,000-\$38,000.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in the document.
