The franchise offered is for the operation of a Dino's Freshmed Grill restaurant which will feature gyros sandwiches, other sandwiches, other Greek food items and other foods and beverages.

The total investment necessary to begin operation of a Dino's Freshmed Grill restaurant is from \$378,000 to \$497,000. This includes the initial franchisee fee of \$30,000. If you sign an Area Development, you pay a lump sum non-refundable Development fee equal to ½ of the Initial Fee for each Restaurant to be opened under the Area Development Agreement.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, us or an affiliate in connection with the proposed franchise sale. Note, however that no government agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on the Disclosure Document alone to understand your contract. Read all of your contract carefully. Show your contract and this Disclosure Document to an advisor, like a lawyer or accountant.

Buying a franchise is a complex investment. The information in this Disclosure Document can help you make up your mind.
