

FRANCHISE DISCLOSURE BOCUMENT

We offer two separate but complementary franchises. A Home Helpers franchise provides non-medical home care aide, personal care aide assistance, and companion care services, and a Direct Link franchise provides personal emergency response products and services.

The total investment necessary to begin operation of a Home Helpers franchise is from \$42,150 to \$57,400. This includes an initial franchise fee for a territory with a population of up to 175,000 of \$31,900 if you pay cash and \$37,900 if we finance a portion of the initial franchise fee, plus \$200 for all or part of every 1,000 people over 175,000. We will finance up to \$20,000 of the initial franchise fee if the population of your purchased territory does not exceed 175,000.

The total investment necessary to begin operation of a Direct Link franchise is from \$29,150 to \$39,400. This includes an initial franchise fee for a territory with a population of up to 175,000 of \$18,900 plus \$200 for all or part of every 1,000 people over 175,000. We do not offer financing for the initial franchise fee for a Direct Link franchise.

If you purchase a Home Helpers franchise and a Direct Link franchise at the same time, your estimated initial investment for both franchises will range from \$44,150 to \$78,300.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement or make any payment in connection with the proposed franchise sale.

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind. Please consider the following RISK FACTORS before you buy this franchise:

- 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION IN OHIO. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN OHIO THAN IN YOUR OWN STATE. THIS PROVISION MAY NOT BE ENFORCEABLE UNDER YOUR STATE'S LAW.
- 2. THE FRANCHISE AGREEMENT STATES THAT OHIO LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
