You and other DKI franchisees are typically independent, established business persons who provide property damage mitigation and/or reconstruction services to customers.

The total investment necessary to begin operation of a DKI franchised business is \$17,145 to \$164,750. This includes an initial franchise fee of \$15,089 to \$122,625, depending on the size of your area of primary responsibility, that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
